**ACQUISITION OF LAND
FOR THE ARMY AND AIR FORCE ORDINANCE, 1925.**

Notice to Treat for the Purchase, Lease, Easement, Rights of User,
or any Right of Interference with land under The
Acquisition of Land for the Army and
Air Force Ordinance, 1925.

To Hasna Salim El Muqasqas

or his/her hereby legally authorised representative and to all other persons, interested in the
land hereafter mentioned or described.

Sec. 4 (2).

1. In pursuance of the provisions of the Acquisition of Land for the Army and Air Force Ordinance, 1925, you and each of you are hereby given notice that the Officer Commanding His Majesty's Royal Air Force in Palestine and Trans-Jordan,

require to expropriate by way of lease for a period of one year
as from 18th November 1940
for the purpose of constructing a Landing Ground.

The lands of which particulars are contained in the schedule hereto which said lands are delineated on the plan numbered hereto and therein coloured No. 1/200/37 available
for inspection at the office of the Mukhtar of Zir'in

Sec. 4 (3).

2. The said Officer Commanding His Majesty's R. A. F. in P. hereby demands of you and each of you the particulars in writing of your interest in the said lands and of the claim or claims made by you and each of you in respect thereof, together with a statement of the amount which you may be willing to receive as compensation and the details of the compensation claimed.

Sec. 3.

3. And he hereby further gives you notice that he is willing to treat and contract for the lease of the same and all subsisting interests therein and for all compensation to be made to you and each of you for damage sustained by reason of the restraint as to any right incidental to ownership which is intended to prohibit or restrict.

Sec. 6.

4. And he hereby further gives notice that you and each of you are required within 15 days after the service of this notice to deliver or cause to be delivered at the office of the Director of Land Registration, Jerusalem particulars of your several interests in the lands hereinbefore referred to or the claims made by you and each of you in respect thereof.

5. And he hereby further gives you notice that if within 15 days of the Service of this notice you fail to state particulars of your claim in respect of such lands or to treat with the Officer Commanding as to the amount of compensation to be paid or if the Officer Commanding and you and each of you do not within such 15 days agree as to the amount of such compensation:

- (a) it shall be lawful for the Officer Commanding to enter into immediate possession of the lands referred to in this notice.
- (b) the amount of compensation shall be settled by the Board of Arbitration in accordance with the provisions of the Acquisition of Land for the Army and Air Force Ordinance, 1925.

Sec. 15.

6. And he hereby further gives you notice that, from or after the service of this notice you and each of you are required to keep the lands in respect thereof free from buildings and other obstructions, and that it shall be lawful for the Officer Commanding at any time after the expiration of 14 days from the service of this notice to enter and pull down any present and future building or structure thereon, and to do any other act thereon authorised in accordance with the provisions of section 15 of the Land Acquisition for the Army and Air Force Ordinance, 1925.
